THE RULE OF LAW

LEGISLATIVE BRANCH

JUDICIAL REVIEW

JUDICIAL REVIEW ALLOWS COURTS TO INVALIDATE LAWS OR EXECUTIVE ACTIONS THAT VIOLATE CONSTITUTIONAL PROVISIONS, PROTECTING INDIVIDUAL RIGHTS AND MAINTAINING THE RULE OF LAW.

EQUAL PROTECTION
