THESE ACCELERATED PROGRAMS OFTEN CULMINATE IN A MASTER'S DEGREE IN OCCUPATIONAL THERAPY (MOT) OR A DOCTORATE IN OCCUPATIONAL THERAPY (OTD), DEPENDING ON THE INSTITUTION. THE FOCUS IS ON DELIVERING CORE OCCUPATIONAL THERAPY KNOWLEDGE ALONGSIDE HANDS-ON CLINICAL PRACTICE TO ENSURE STUDENTS MEET PROFESSIONAL COMPETENCY STANDARDS.

MANY PROGRAMS ARE DESIGNED FOR STUDENTS WHO HAVE ALREADY COMPLETED PREREQUISITE COURSEWORK IN SUBJECTS SUCH AS ANATOMY, PHYSIOLOGY, PSYCHOLOGY, AND STATISTICS. THIS PRIOR ACADEMIC FOUNDATION ALLOWS THE CURRICULUM TO CONCENTRATE ON SPECIALIZED OCCUPATIONAL THERAPY TOPICS AND PRACTICAL SKILLS. - LETTERS OF RECOMMENDATION FROM ACADEMIC OR PROFESSIONAL REFERENCES

- PERSONAL STATEMENTS OR ESSAYS OUTLINING CAREER GOALS AND MOTIVATIONS
- RELEVANT VOLUNTEER OR WORK EXPERIENCE IN HEALTHCARE OR REHABILITATION SETTINGS
- STANDARDIZED TEST SCORES (E.G., GRE), DEPENDING ON THE PROGRAM
- INTERVIEW PROCESSES TO ASSESS INTERPERSONAL SKILLS AND SUITABILITY FOR THE PROFESSION

MEETING THESE REQUIREMENTS IS ESSENTIAL TO GAIN ACCEPTANCE INTO COMPETITIVE ACCELERATED PROGRAMS THAT MAINTAIN RIGOROUS ACADEMIC AND CLINICAL STANDARDS.

ACCREDITATION AND LICENSING CONSIDERATIONS

CHOOSING AN ACCREDITED 2 YEAR OCCUPATIONAL THERAPY PROGRAM IS CRUCIAL TO ENSURE THE QUALITY OF EDUCATION AND ELIGIBILITY FOR LICENSURE. ACCREDITATION IS TYPICALLY GRANTED BY THE ACCREDITATION COUNCIL FOR OCCUPATIONAL THERAPY EDUCATION (ACOTE), WHICH SETS STANDARDS FOR CURRICULUM, FACULTY QUALIFICATIONS, CLINICAL EXPERIENCES, AND STUDENT OUTCOMES.

GRADUATES OF AN ACOTE-ACCREDITED PROGRAM ARE ELIGIBLE TO SIT FOR THE NATIONAL BOARD FOR CERTIFICATION IN OCCUPATIONAL THERAPY (NBCOT) EXAM. PASSING THIS EXAM IS A KEY STEP TOWARD OBTAINING STATE LICENSURE, WHICH IS MANDATORY TO PRACTICE AS A LICENSED OCCUPATIONAL THERAPIST IN THE UNITED STATES.

IT IS IMPORTANT FOR PROSPECTIVE STUDENTS TO VERIFY THE ACCREDITATION STATUS OF PROGRAMS BEFORE ENROLLMENT, AS NON-ACCREDITED PROGRAMS MAY NOT QUALIFY GRADUATES FOR CERTIFICATION AND LICENSURE.

CAREER OPPORTUNITIES AND JOB OUTLOOK

GRADUATES OF 2 YEAR OCCUPATIONAL THERAPY PROGRAMS ARE WELL-POSITIONED TO ENTER A GROWING JOB MARKET.
