Lord Myners' assertion that his precept to the RBS Board - that there should be no reward for failure - did not represent an adequate oversight of the remuneration of outgoing senior bank staff, and the report casts doubt on the Treasury's decision to rely on the then RBS Board to handle negotiations with these staff without direct Treasury involvement. The financial crisis has exposed serious flaws and shortcomings in the system of non-executive oversight of bank executives. Three problems are noted: the lack of time many non-executives commit to their role, with many combining a senior full-time position with multiple non-executive directorships; in many instances a lack of expertise; and a lack of diversity. The failure of institutional investors effectively to scrutinise and monitor the decision of boards and executive management in the banking sector may reflect the low priority some institutional investors have accorded to governance issues; in some cases, they may have even encouraged the risk-taking that proved the downfall of some banks.
