DETECTION WINDOW

HAIR TREATMENTS AND BLEACHING

BLEACHING, DYEING, OR CHEMICALLY TREATING HAIR CAN SOMETIMES DEGRADE DRUG METABOLITES, POTENTIALLY LOWERING THEIR DETECTABILITY. HOWEVER, EXTENSIVE HAIR TREATMENTS MAY ALSO DAMAGE THE HAIR, RAISING SUSPICION DURING SAMPLE COLLECTION. MOREOVER, THESE METHODS DO NOT GUARANTEE COMPLETE REMOVAL OF DRUG TRACES.

SHAVING THE HAIR

SOME INDIVIDUALS ATTEMPT TO AVOID HAIR FOLLICLE TESTING BY SHAVING THEIR HEAD OR BODY HAIR COMPLETELY. THIS TACTIC MAY RESULT IN RESCHEDULING THE TEST OR SWITCHING TO ALTERNATIVE TESTING METHODS SUCH AS URINE OR BLOOD TESTS. HOWEVER, REPEATED REFUSAL OR ABSENCE OF HAIR CAN BE INTERPRETED AS AN ATTEMPT TO EVADE TESTING, LEADING TO NEGATIVE CONSEQUENCES.

TIME AND ABSTINENCE

THE MOST RELIABLE WAY TO BEAT A HAIR FOLLICLE TEST IS TO ABSTAIN FROM DRUG USE FOR THE DURATION OF THE DETECTION WINDOW, GENERALLY THREE MONTHS. SINCE HAIR GROWS SLOWLY, ONLY STOPPING DRUG USE WELL IN ADVANCE CAN ENSURE A CLEAN RESULT.
