UNDERSTANDING THE BILL OF RIGHTS

THE BILL OF RIGHTS REFERS TO THE FIRST TEN AMENDMENTS TO THE UNITED STATES CONSTITUTION, RATIFIED IN 1791. THESE AMENDMENTS WERE DESIGNED TO PROTECT INDIVIDUAL LIBERTIES AND LIMIT GOVERNMENT POWER.
