CERTIFICATIONS

OBTAINING INDUSTRY-RECOGNIZED CERTIFICATIONS GREATLY IMPACTS BILLING AND CODING SALARY IN NC. REGIONAL SALARY VARIATIONS WITHIN NORTH CAROLINA

THESE METROPOLITAN AREAS HOST NUMEROUS HOSPITALS, SPECIALTY CLINICS, AND INSURANCE COMPANIES, CREATING A HIGHER DEMAND FOR SKILLED CODING EXPERTS. THE COMPETITIVE JOB MARKET IN THESE CITIES OFTEN DRIVES SALARIES UPWARD.

RURAL AND SUBURBAN AREAS

IN CONTRAST, RURAL AND SUBURBAN PARTS OF NORTH CAROLINA TEND TO OFFER LOWER BILLING AND CODING SALARIES. SMALLER HEALTHCARE PROVIDERS AND FEWER LARGE MEDICAL CENTERS LIMIT EARNING POTENTIAL. HOWEVER, THE LOWER COST OF LIVING IN THESE AREAS MAY OFFSET THE SALARY DIFFERENCES TO SOME EXTENT.

EDUCATIONAL REQUIREMENTS AND CERTIFICATIONS

- **CERTIFIED CODING SPECIALIST (CCS):** PROVIDED BY AHIMA, IDEAL FOR HOSPITAL AND INPATIENT CODING.
- **CERTIFIED BILLING AND CODING SPECIALIST (CBCS):** FOCUSES ON BOTH CODING AND BILLING PROCESSES FOR ENTRY-LEVEL PROFESSIONALS.

HOLDING ONE OR MORE OF THESE CERTIFICATIONS DEMONSTRATES EXPERTISE AND OFTEN LEADS TO HIGHER BILLING AND CODING SALARY IN NC.

CAREER ADVANCEMENT AND SALARY GROWTH OPPORTUNITIES
