- ERBIUM:YAG LASER THERAPY
- PULSE DYE LASER THERAPY

UNDERSTANDING CPT CODES FOR LASER THERAPY

CPT CODES ARE A STANDARDIZED SET OF NUMERIC CODES ESTABLISHED BY THE AMERICAN MEDICAL ASSOCIATION TO DESCRIBE MEDICAL, SURGICAL, AND DIAGNOSTIC SERVICES. THE CPT CODE FOR LASER THERAPY DEPENDS ON THE SPECIFIC PROCEDURE AND THE BODY AREA TREATED. LASER THERAPY SERVICES FALL UNDER VARIOUS CATEGORIES WITHIN THE CPT MANUAL, INCLUDING PHYSICAL MEDICINE AND REHABILITATION, DERMATOLOGY, AND SURGERY. PROVIDERS MUST SELECT THE APPROPRIATE CPT CODE THAT ACCURATELY REFLECTS THE SERVICE PERFORMED TO ENSURE PROPER BILLING AND REIMBURSEMENT. THE CORRECT USE OF CPT CODES FOR LASER THERAPY REDUCES CLAIM DENIALS AND SUPPORTS COMPLIANCE WITH PAYER POLICIES.

CATEGORIES RELEVANT TO LASER THERAPY

LASER THERAPY PROCEDURES MAY BE CODED UNDER MULTIPLE CPT CATEGORIES, DEPENDING ON THE CONTEXT:

96920 - PHOTOTHERAPY, ULTRAVIOLET (UV) LIGHT

THOUGH PRIMARILY FOR UV LIGHT TREATMENT, THIS CODE SOMETIMES INTERSECTS WITH LIGHT-BASED THERAPIES BUT IS GENERALLY NOT USED FOR LASER THERAPY.

LASER SURGERY CODES

LASER SURGICAL PROCEDURES HAVE DEDICATED CPT CODES, WHICH VARY BASED ON THE ANATOMICAL SITE AND TYPE OF SURGERY PERFORMED. EXAMPLES INCLUDE:

- 17106 - DESTRUCTION OF BENIGN LESIONS BY LASER
- 17107 - DESTRUCTION OF MALIGNANT LESIONS BY LASER
- 15781 - LASER EXCISION OF SKIN OR MUCOUS MEMBRANE LESION

ADDITIONAL CODES FOR SPECIFIC APPLICATIONS

IN SOME CASES, LASER THERAPY MAY BE PART OF A BROADER TREATMENT PLAN AND CODED ALONG WITH OTHER EVALUATION AND MANAGEMENT CODES. PROPER IDENTIFICATION OF THE PRIMARY PROCEDURE IS ESSENTIAL.

GUIDELINES FOR ACCURATE CODING AND BILLING
