CPT CODE FOR FEEDING THERAPY REFERS TO THE SPECIFIC CURRENT PROCEDURAL TERMINOLOGY (CPT) CODES USED BY HEALTHCARE PROVIDERS TO BILL AND DOCUMENT FEEDING THERAPY SERVICES. UNDERSTANDING FEEDING THERAPY

FEEDING THERAPY IS A SPECIALIZED CLINICAL SERVICE DESIGNED TO ASSIST INDIVIDUALS WHO HAVE DIFFICULTIES WITH EATING, SWALLOWING, OR ORAL MOTOR SKILLS. THESE CHALLENGES MAY BE CAUSED BY DEVELOPMENTAL DELAYS, NEUROLOGICAL DISORDERS, MEDICAL CONDITIONS, OR STRUCTURAL ABNORMALITIES. FEEDING THERAPY IS TYPICALLY PROVIDED BY SPEECH-LANGUAGE PATHOLOGISTS (SLPs), OCCUPATIONAL THERAPISTS, OR OTHER TRAINED HEALTHCARE PROFESSIONALS WHO ASSESS AND TREAT FEEDING AND SWALLOWING DYSFUNCTIONS.

SCOPE OF FEEDING THERAPY

THE PRIMARY GOALS OF FEEDING THERAPY INCLUDE IMPROVING ORAL MOTOR SKILLS, ENHANCING SWALLOWING SAFETY, INCREASING NUTRITIONAL INTAKE, AND REDUCING THE RISK OF ASPIRATION OR CHOKING. THERAPY SESSIONS MAY INVOLVE EXERCISES TO STRENGTHEN MUSCLES INVOLVED IN CHEWING AND SWALLOWING, SENSORY INTEGRATION TECHNIQUES, MODIFICATION OF FOOD TEXTURES, AND EDUCATION FOR CAREGIVERS ON FEEDING STRATEGIES.

PATIENT POPULATIONS

FEEDING THERAPY IS APPLICABLE FOR VARIOUS AGE GROUPS, FROM INFANTS WITH CONGENITAL CONDITIONS TO ELDERLY PATIENTS WITH NEURODEGENERATIVE DISEASES. COMMON PATIENT POPULATIONS INCLUDE CHILDREN WITH AUTISM SPECTRUM DISORDER, CEREBRAL PALSY, OR PREMATURITY, AS WELL AS ADULTS RECOVERING FROM STROKE OR TRAUMATIC BRAIN INJURY.

RELEVANT CPT CODES FOR FEEDING THERAPY

USING THE CORRECT CPT CODES IS CRUCIAL FOR DOCUMENTING FEEDING THERAPY SERVICES AND OBTAINING PROPER

REIMBURSEMENT. CPT CODES ARE MAINTAINED BY THE AMERICAN MEDICAL ASSOCIATION AND ARE UPDATED ANNUALLY TO REFLECT CURRENT MEDICAL PRACTICES. SEVERAL CODES MAY APPLY TO FEEDING THERAPY DEPENDING ON THE SERVICE SETTING, PROVIDER TYPE, AND PROCEDURE PERFORMED.

CPT CODES COMMONLY USED IN FEEDING THERAPY

THE FOLLOWING ARE THE PRIMARY CPT CODES FREQUENTLY USED WHEN BILLING FOR FEEDING THERAPY SERVICES:

- **92526** - TREATMENT OF SWALLOWING DYSFUNCTION AND/OR ORAL FUNCTION FOR FEEDING
- **92521** - EVALUATION OF SPEECH FLUENCY (MAY INCLUDE FEEDING EVALUATION IF RELATED TO ORAL MOTOR FUNCTION)
- **92523** - EVALUATION OF SPEECH SOUND PRODUCTION (MAY BE USED IF FEEDING ASSESSMENT IS PART OF A COMPREHENSIVE SPEECH EVALUATION)
- **92610** - EVALUATION OF ORAL AND PHARYNGEAL SWALLOWING FUNCTION
- **96127** - BRIEF EMOTIONAL/BEHAVIORAL ASSESSMENT (MAY BE RELEVANT IF BEHAVIORAL FEEDING ISSUES ARE ADDRESSED)

AMONG THESE, **CPT CODE 92526** IS THE MOST SPECIFIC AND WIDELY RECOGNIZED CODE FOR FEEDING THERAPY TREATMENT SESSIONS. THIS CODE COVERS DIRECT INTERVENTIONS THAT ADDRESS SWALLOWING DYSFUNCTION OR ORAL FUNCTION RELATED TO FEEDING.

MODIFIERS AND ADDITIONAL CODES

IN SOME CASES, MODIFIERS MAY BE REQUIRED TO INDICATE MULTIPLE PROCEDURES OR SPECIFIC BILLING CIRCUMSTANCES, SUCH AS:

- **MODIFIER 59** TO INDICATE DISTINCT PROCEDURAL SERVICES
- **MODIFIER GP** TO DENOTE SERVICES PROVIDED UNDER PHYSICAL THERAPY PLANS
- **MODIFIER 52** FOR REDUCED SERVICES

ADDITIONALLY, EVALUATION CODES SUCH AS 92610 MAY BE USED PRIOR TO TREATMENT TO ASSESS THE PATIENT'S SWALLOWING FUNCTION THOROUGHLY. SELECTING APPROPRIATE CODES DEPENDS ON THE CLINICAL DOCUMENTATION AND SCOPE OF SERVICES RENDERED.

DOCUMENTATION AND BILLING GUIDELINES

PROPER DOCUMENTATION IS ESSENTIAL FOR SUPPORTING THE USE OF FEEDING THERAPY CPT CODES AND ENSURING COMPLIANCE WITH PAYER POLICIES. ACCURATE RECORDS HELP JUSTIFY MEDICAL NECESSITY AND FACILITATE SMOOTH CLAIMS PROCESSING.

REQUIRED DOCUMENTATION ELEMENTS

DOCUMENTATION FOR FEEDING THERAPY SHOULD INCLUDE:

- PATIENT HISTORY AND PRESENTING FEEDING/SWALLOWING DIFFICULTIES

- RESULTS FROM CLINICAL OR INSTRUMENTAL SWALLOWING EVALUATIONS
- THERAPY GOALS AND TREATMENT PLAN SPECIFIC TO FEEDING
- DESCRIPTION OF THERAPEUTIC INTERVENTIONS PROVIDED DURING EACH SESSION
- PATIENT PROGRESS AND RESPONSE TO THERAPY

BILLING CONSIDERATIONS

WHEN BILLING FOR FEEDING THERAPY, PROVIDERS SHOULD ENSURE THAT THE CPT CODES BILLED ACCURATELY REFLECT THE SERVICES DELIVERED. IT IS IMPORTANT TO VERIFY PAYER-SPECIFIC GUIDELINES, AS SOME INSURERS MAY REQUIRE PREAUTHORIZATION OR HAVE LIMITATIONS ON THE FREQUENCY OR DURATION OF THERAPY SESSIONS. USING THE APPROPRIATE CPT CODES AVOIDS CLAIM DENIALS AND FACILITATES TIMELY REIMBURSEMENT.

COMMON CHALLENGES AND SOLUTIONS IN CODING FEEDING THERAPY

HEALTHCARE PROVIDERS OFTEN ENCOUNTER CHALLENGES WHEN CODING AND BILLING FOR FEEDING THERAPY DUE TO THE COMPLEXITY OF SERVICES AND VARIABILITY IN PAYER REQUIREMENTS. UNDERSTANDING THESE CHALLENGES HELPS IMPROVE CODING ACCURACY AND REDUCE ADMINISTRATIVE BURDENS.

CHALLENGE: DIFFERENTIATING FEEDING THERAPY FROM OTHER SPEECH SERVICES

FEEDING THERAPY CAN OVERLAP WITH OTHER SPEECH-LANGUAGE PATHOLOGY SERVICES, MAKING IT DIFFICULT TO SELECT THE CORRECT CPT CODE. TO ADDRESS THIS, PROVIDERS SHOULD CLEARLY DOCUMENT THE SPECIFIC FEEDING OR SWALLOWING TREATMENT PROVIDED AND USE CODE 92526 EXCLUSIVELY FOR FEEDING THERAPY TREATMENT SESSIONS.

CHALLENGE: INSURANCE COVERAGE LIMITATIONS

SOME INSURANCE PLANS HAVE LIMITED COVERAGE FOR FEEDING THERAPY OR REQUIRE EXTENSIVE DOCUMENTATION FOR MEDICAL NECESSITY. PROVIDERS SHOULD FAMILIARIZE THEMSELVES WITH INDIVIDUAL PAYER POLICIES AND OBTAIN NECESSARY AUTHORIZATIONS BEFORE INITIATING THERAPY.

CHALLENGE: PROPER USE OF EVALUATION AND TREATMENT CODES

PROVIDERS MUST DISTINGUISH BETWEEN EVALUATION CODES (SUCH AS 92610) AND TREATMENT CODES (SUCH AS 92526) TO AVOID CODING ERRORS. EVALUATION CODES ARE USED FOR ASSESSMENTS, WHILE TREATMENT CODES APPLY TO ONGOING THERAPY SESSIONS.

TIPS FOR ACCURATE CODING AND REIMBURSEMENT

OPTIMIZING CODING PRACTICES FOR FEEDING THERAPY ENHANCES REIMBURSEMENT AND REDUCES CLAIM DENIALS. THE FOLLOWING TIPS CAN ASSIST HEALTHCARE PROFESSIONALS IN MAINTAINING COMPLIANCE AND EFFICIENCY.

1. **STAY UPDATED:** REGULARLY REVIEW CPT CODE UPDATES AND PAYER POLICIES RELATED TO FEEDING THERAPY.
2. **COMPREHENSIVE DOCUMENTATION:** MAINTAIN DETAILED RECORDS THAT CLEARLY OUTLINE THE CLINICAL RATIONALE AND

SERVICES PROVIDED.

3. **USE SPECIFIC CODES:** APPLY THE MOST PRECISE CPT CODES, SUCH AS 92526 FOR FEEDING THERAPY TREATMENT, TO REFLECT ACTUAL SERVICES.
4. **VERIFY COVERAGE:** CONFIRM INSURANCE BENEFITS AND OBTAIN PREAUTHORIZATION WHEN REQUIRED TO PREVENT CLAIM DENIALS.
5. **EDUCATE BILLING STAFF:** TRAIN ADMINISTRATIVE PERSONNEL ON FEEDING THERAPY CODING NUANCES TO ENSURE ACCURATE CLAIM SUBMISSION.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE CPT CODE FOR FEEDING THERAPY?

THE COMMON CPT CODE FOR FEEDING THERAPY IS 92526, WHICH REFERS TO TREATMENT OF SWALLOWING DYSFUNCTION AND/OR ORAL FUNCTION FOR FEEDING.

IS FEEDING THERAPY COVERED BY INSURANCE USING CPT CODES?

FEEDING THERAPY IS OFTEN COVERED BY INSURANCE WHEN BILLED WITH THE APPROPRIATE CPT CODE LIKE 92526, BUT COVERAGE DEPENDS ON THE INDIVIDUAL INSURANCE PLAN AND MEDICAL NECESSITY.

CAN CPT CODE 92526 BE USED FOR PEDIATRIC FEEDING THERAPY?

YES, CPT CODE 92526 IS FREQUENTLY USED FOR PEDIATRIC FEEDING THERAPY TO ADDRESS SWALLOWING AND ORAL FEEDING DIFFICULTIES.

ARE THERE DIFFERENT CPT CODES FOR FEEDING THERAPY VERSUS SPEECH THERAPY?

YES, FEEDING THERAPY TYPICALLY USES CPT CODE 92526, WHILE SPEECH THERAPY USES DIFFERENT CODES SUCH AS 92507 FOR SPEECH EVALUATION OR 92508 FOR SPEECH THERAPY.

HOW IS CPT CODE 92526 DEFINED IN TERMS OF SERVICES PROVIDED?

CPT CODE 92526 IS DEFINED AS TREATMENT OF SWALLOWING DYSFUNCTION AND/OR ORAL FUNCTION FOR FEEDING, INCLUDING THERAPY TO IMPROVE FEEDING SKILLS AND SWALLOWING SAFETY.

CAN OCCUPATIONAL THERAPISTS USE CPT CODE 92526 FOR FEEDING THERAPY?

YES, OCCUPATIONAL THERAPISTS WHO PROVIDE FEEDING THERAPY SERVICES CAN USE CPT CODE 92526 TO BILL FOR TREATMENT OF SWALLOWING AND FEEDING DYSFUNCTION.

IS A REFERRAL REQUIRED TO USE CPT CODE 92526 FOR FEEDING THERAPY?

A REFERRAL FROM A PHYSICIAN OR QUALIFIED HEALTHCARE PROVIDER IS OFTEN REQUIRED BY INSURANCE COMPANIES TO USE CPT CODE 92526 FOR FEEDING THERAPY REIMBURSEMENT.

HOW OFTEN CAN CPT CODE 92526 BE BILLED FOR FEEDING THERAPY SESSIONS?

CPT CODE 92526 CAN BE BILLED FOR EACH INDIVIDUAL FEEDING THERAPY SESSION PROVIDED, BUT FREQUENCY LIMITS MAY BE

SET BY INSURANCE PLANS OR MEDICAL GUIDELINES.

ARE THERE ANY MODIFIERS COMMONLY USED WITH CPT CODE 92526?

MODIFIERS SUCH AS -59 (DISTINCT PROCEDURAL SERVICE) OR -GN (SPEECH-LANGUAGE PATHOLOGY SERVICES) MAY BE APPENDED TO CPT CODE 92526 DEPENDING ON THE BILLING CONTEXT AND PAYER REQUIREMENTS.
