OVERVIEW OF NEGATIVE PRESSURE WOUND THERAPY

NEGATIVE PRESSURE WOUND THERAPY IS AN ADVANCED WOUND CARE TREATMENT THAT USES CONTROLLED SUCTION TO PROMOTE HEALING IN ACUTE, CHRONIC, AND COMPLEX WOUNDS. DUE TO ITS SPECIALIZED NATURE, NPWT REQUIRES PRECISE CODING TO REFLECT THE TYPE OF SERVICE PROVIDED, DURATION OF THERAPY, AND SPECIFIC DEVICES USED. THE INTEGRATION OF CPT CODES FOR NEGATIVE PRESSURE WOUND THERAPY ENSURES ACCURATE COMMUNICATION BETWEEN HEALTHCARE PROVIDERS AND PAYERS REGARDING THE TREATMENT RENDERED.

CLINICAL APPLICATIONS OF NPWT

UNDERSTANDING CPT CODES FOR NEGATIVE PRESSURE WOUND THERAPY

CPT CODES FOR NEGATIVE PRESSURE WOUND THERAPY ARE DESIGNED TO CATEGORIZE AND DESCRIBE THE SERVICES PROVIDED DURING THE TREATMENT PROCESS. THESE CODES ARE ESSENTIAL FOR INSURANCE REIMBURSEMENT AND MUST ACCURATELY REPRESENT THE PROCEDURES PERFORMED. THE PRIMARY CPT CODES USED FOR NPWT INCLUDE 97607, 97608, AND 97605, EACH REFLECTING SPECIFIC ASPECTS OF THE THERAPY.

KEY CPT CODES FOR NPWT

- **97607:** THIS CODE IS USED FOR THE APPLICATION OF NEGATIVE PRESSURE WOUND THERAPY USING A DEVICE THAT DELIVERS CONTROLLED SUCTION TO THE WOUND SITE. IT COVERS THE INITIAL SETUP AND APPLICATION OF THE NPWT SYSTEM.
- **97608:** THIS CODE PERTAINS TO THE MANAGEMENT AND REPLACEMENT OF NPWT DRESSINGS, INCLUDING THE REMOVAL OF OLD DRESSINGS AND REAPPLICATION OF NEW ONES, TYPICALLY PERFORMED DURING FOLLOW-UP VISITS.
- **97605:** WHILE NOT EXCLUSIVE TO NPWT, THIS CODE IS USED FOR THE TREATMENT OF OPEN WOUNDS, MAKING IT RELEVANT WHEN NPWT IS PART OF A BROADER WOUND CARE REGIMEN.

EACH CPT CODE REFLECTS DIFFERENT STAGES OR COMPONENTS OF NPWT, MAKING IT IMPERATIVE TO SELECT THE CORRECT CODE BASED ON THE SERVICE PROVIDED DURING THE PATIENT ENCOUNTER.

CODING GUIDELINES AND DOCUMENTATION REQUIREMENTS

ACCURATE CODING FOR NEGATIVE PRESSURE WOUND THERAPY RELIES HEAVILY ON COMPREHENSIVE AND PRECISE DOCUMENTATION. THE DOCUMENTATION MUST INCLUDE DETAILS ABOUT THE WOUND SIZE, TYPE, LOCATION, AND THE SPECIFIC NPWT TECHNIQUES UTILIZED. PROPER RECORDING ENSURES COMPLIANCE WITH PAYER POLICIES AND SUPPORTS THE MEDICAL NECESSITY OF THE THERAPY.

ESSENTIAL DOCUMENTATION ELEMENTS

TO JUSTIFY THE USE OF CPT CODES FOR NPWT, HEALTHCARE PROVIDERS SHOULD DOCUMENT THE FOLLOWING:

- WOUND DESCRIPTION, INCLUDING SIZE (LENGTH, WIDTH, DEPTH) AND CONDITION
- TYPE OF NPWT DEVICE APPLIED
- DATE AND TIME OF THERAPY APPLICATION OR DRESSING CHANGE
- DURATION OF NPWT SESSIONS
- CLINICAL RATIONALE FOR NPWT USE
- PATIENT RESPONSE AND WOUND PROGRESS

FAILURE TO CAPTURE THESE ELEMENTS CAN RESULT IN CLAIM DENIALS OR AUDITS, UNDERSCORING THE IMPORTANCE OF THOROUGH RECORD-KEEPING ALIGNED WITH CPT CODING STANDARDS.

COMMON BILLING CHALLENGES AND SOLUTIONS

FREQUENTLY ASKED QUESTIONS

WHAT IS CPT CODE FOR NEGATIVE PRESSURE WOUND THERAPY (NPWT)?

THE MOST COMMONLY USED CPT CODES FOR NEGATIVE PRESSURE WOUND THERAPY ARE 97605 AND 97606, WHERE 97605 IS FOR NPWT APPLICATION TO AN OPEN WOUND LESS THAN OR EQUAL TO 50 SQUARE CENTIMETERS, AND 97606 IS FOR WOUNDS GREATER THAN 50 SQUARE CENTIMETERS.

WHEN SHOULD CPT CODE 97605 BE USED FOR NPWT?

CPT CODE 97605 SHOULD BE USED WHEN NEGATIVE PRESSURE WOUND THERAPY IS APPLIED TO A WOUND THAT IS LESS THAN

OR EQUAL TO 50 SQUARE CENTIMETERS IN SIZE.

How is CPT code 97606 different from 97605 in NPWT billing?

CPT code 97606 is used for negative pressure wound therapy applied to wounds larger than 50 square centimeters, whereas 97605 is for wounds 50 square centimeters or smaller.

Can NPWT CPT codes 97605 and 97606 be billed multiple times on the same day?

Generally, CPT codes 97605 and 97606 are billed once per day per wound. Multiple treatments on the same day may not be separately billable unless they are for distinct wounds.

Is there a specific CPT code for NPWT with instillation?

Yes, CPT code 97607 (for wounds ≤ 50 sq cm) and 97608 (for wounds > 50 sq cm) cover negative pressure wound therapy with instillation and dwell time.

What documentation is required to support billing of NPWT CPT codes?

Documentation must include wound size, description, therapy settings, frequency of dressing changes, clinical indications, and patient response to therapy to justify use of NPWT CPT codes 97605 or 97606.

Are there any recent updates to CPT coding for negative pressure wound therapy?
