The aim of this annual event is to offer post qualification training and a forum for discussion in areas of current clinical interest. Over the years, the course has attracted national and international speakers and attenders of the highest calibre, plus up-to-the-minute reports on current research. In August 1984, the course was held, for the first time, in the beautiful old city of Chester.
