UNLIKE CREATININE, CYSTATIN C LEVELS ARE LESS AFFECTED BY MUSCLE MASS, MAKING IT A POTENTIALLY MORE RELIABLE INDICATOR OF KIDNEY FUNCTION ACROSS DIVERSE POPULATIONS.

ROLE OF CYSTATIN C IN KIDNEY FUNCTION ASSESSMENT

NORMAL AND ABNORMAL LEVELS
