OVERVIEW OF FORD MOTOR COMPANY DRUG TEST POLICY

FORD MOTOR COMPANY MAINTAINS A STRICT DRUG TESTING POLICY DESIGNED TO PROMOTE WORKPLACE SAFETY AND COMPLIANCE WITH FEDERAL AND STATE LAWS. TYPES OF DRUG TESTS ADMINISTERED

URINE DRUG TESTING

IN SOME CASES, FORD PROVIDES ACCESS TO EMPLOYEE ASSISTANCE PROGRAMS (EAPs) THAT OFFER COUNSELING, TREATMENT REFERRALS, AND SUPPORT FOR INDIVIDUALS STRUGGLING WITH SUBSTANCE ABUSE. THIS APPROACH HELPS EMPLOYEES REGAIN THEIR HEALTH AND RETURN TO PRODUCTIVE WORK.

EMPLOYEE ASSISTANCE PROGRAMS AND SUPPORT
