## UNDERSTANDING FORENSIC PEER SUPPORT TRAINING

THE GOAL IS TO DEVELOP A NETWORK OF TRAINED PEERS WHO CAN RECOGNIZE SIGNS OF STRESS, OFFER IMMEDIATE ASSISTANCE, AND FACILITATE ACCESS TO PROFESSIONAL RESOURCES WHEN NECESSARY.

## THE ROLE OF PEER SUPPORT IN FORENSIC SETTINGS

PEER SUPPORT IN FORENSIC SETTINGS INVOLVES COLLEAGUES HELPING EACH OTHER COPE WITH OCCUPATIONAL STRESSORS BY SHARING EXPERIENCES, PROVIDING EMPATHY, AND FOSTERING A SENSE OF COMMUNITY. UNLIKE TRADITIONAL COUNSELING, PEER SUPPORT IS INFORMAL AND RELIES ON MUTUAL UNDERSTANDING WITHIN THE PROFESSIONAL CONTEXT. TRAINING ENSURES PEERS CAN EFFECTIVELY IDENTIFY PSYCHOLOGICAL DISTRESS, MAINTAIN CONFIDENTIALITY, AND RESPOND APPROPRIATELY WITHOUT OVERSTEPPING THEIR ROLE.

## TARGET AUDIENCE FOR FORENSIC PEER SUPPORT TRAINING

TO SUSTAIN THEIR ABILITY TO SUPPORT OTHERS, PEER SUPPORTERS ARE TAUGHT SELF-CARE STRATEGIES AND RESILIENCE TECHNIQUES. THIS COMPONENT HELPS PREVENT BURNOUT AND ENSURES THAT SUPPORTERS REMAIN EFFECTIVE AND HEALTHY IN THEIR ROLES.

## BENEFITS OF FORENSIC PEER SUPPORT TRAINING

## ONGOING SUPERVISION AND SUPPORT

PEER SUPPORTERS REQUIRE CONTINUAL SUPERVISION, ACCESS TO PROFESSIONAL CONSULTATION, AND OPPORTUNITIES FOR SKILL REFRESHMENT. REGULAR MEETINGS AND PEER NETWORKING FOSTER A SUSTAINED, EFFECTIVE SUPPORT SYSTEM.
