UNDERSTANDING THE PURPOSE OF "I HAVE RIGHTS" WORKSHEETS

"I HAVE RIGHTS" WORKSHEETS SERVE AS EDUCATIONAL TOOLS DESIGNED TO INTRODUCE STUDENTS TO THE CONCEPT OF INDIVIDUAL RIGHTS AND FREEDOMS. DEFINITION AND SCOPE OF RIGHTS

COMMON QUESTIONS IN "I HAVE RIGHTS" WORKSHEETS

SAMPLE QUESTION: WHAT SHOULD YOU DO IF YOU FEEL YOUR RIGHTS ARE BEING VIOLATED?

ANSWER: IF YOU BELIEVE YOUR RIGHTS ARE BEING VIOLATED, YOU SHOULD INFORM A TRUSTED ADULT SUCH AS A TEACHER, PARENT, OR COUNSELOR. IT MAY ALSO BE NECESSARY TO SEEK HELP FROM APPROPRIATE AUTHORITIES OR ADVOCACY GROUPS THAT PROTECT INDIVIDUAL RIGHTS.

SAMPLE QUESTION: HOW DO RIGHTS AND RESPONSIBILITIES RELATE TO EACH OTHER?

ANSWER: RIGHTS AND RESPONSIBILITIES ARE INTERCONNECTED; WHILE INDIVIDUALS HAVE RIGHTS, THEY ALSO HAVE RESPONSIBILITIES TO RESPECT THE RIGHTS OF OTHERS AND CONTRIBUTE POSITIVELY TO THEIR COMMUNITY. EXERCISING RIGHTS RESPONSIBLY HELPS ENSURE THAT EVERYONE'S RIGHTS ARE PROTECTED.

SAMPLE QUESTION: CAN RIGHTS EVER BE LIMITED? IF SO, WHY?

ANSWER: YES, RIGHTS CAN SOMETIMES BE LIMITED TO PROTECT THE RIGHTS AND SAFETY OF OTHERS OR TO MAINTAIN PUBLIC ORDER. FOR EXAMPLE, FREEDOM OF SPEECH DOES NOT ALLOW FOR HATE SPEECH OR INCITING VIOLENCE. SUCH LIMITATIONS MUST BE LAWFUL, NECESSARY, AND PROPORTIONATE.
