SYMBOLISM AND ITS ROLE

SYMBOLISM IN THE SPEECH EXTENDS BEYOND INDIVIDUAL METAPHORS. THE “DREAM” ITSELF SYMBOLIZES HOPE, ASPIRATION, AND THE POSSIBILITY OF A TRANSFORMED SOCIETY. ADDITIONALLY, REFERENCES TO MOUNTAINS, HILLS, AND VALLEYS SYMBOLIZE THE CHALLENGES AND PROGRESS IN THE CIVIL RIGHTS MOVEMENT. IMAGERY AND SENSORY LANGUAGE
