OVERVIEW OF ILLINOIS HARASSMENT TRAINING REQUIREMENT

WHO IS REQUIRED TO COMPLETE HARASSMENT TRAINING IN ILLINOIS?

ILLINOIS LAW SPECIFIES PARTICULAR CATEGORIES OF EMPLOYEES AND EMPLOYERS SUBJECT TO THE HARASSMENT TRAINING REQUIREMENT. GENERALLY, THE MANDATE APPLIES TO EMPLOYERS WITH AT LEAST ONE EMPLOYEE, INCLUDING GOVERNMENT AGENCIES AND PRIVATE SECTOR BUSINESSES. BOTH SUPERVISORS AND NON-SUPERVISORY EMPLOYEES ARE REQUIRED TO COMPLETE TRAINING, WITH ADDITIONAL EMPHASIS ON SUPERVISORY PERSONNEL DUE TO THEIR ROLES IN MANAGING TEAMS AND RESPONDING TO COMPLAINTS.

EMPLOYERS COVERED BY THE REQUIREMENT

ALL EMPLOYERS IN ILLINOIS WITH ONE OR MORE EMPLOYEES MUST COMPLY WITH THE HARASSMENT TRAINING REQUIREMENT. THIS INCLUDES:

- PRIVATE COMPANIES OPERATING WITHIN ILLINOIS

- STATE AND LOCAL GOVERNMENT AGENCIES
- NONPROFIT ORGANIZATIONS THAT EMPLOY WORKERS

THIS BROAD COVERAGE ENSURES THAT HARASSMENT PREVENTION EDUCATION REACHES DIVERSE WORKPLACES ACROSS THE STATE.

EMPLOYEE CATEGORIES

BOTH SUPERVISORY AND NON-SUPERVISORY EMPLOYEES MUST COMPLETE HARASSMENT TRAINING, ALTHOUGH SUPERVISORY EMPLOYEES OFTEN RECEIVE MORE DETAILED INSTRUCTION. SUPERVISORS ARE TRAINED ON HOW TO RECOGNIZE HARASSMENT, PROPERLY HANDLE COMPLAINTS, AND MAINTAIN A HARASSMENT-FREE WORKPLACE. NON-SUPERVISORY EMPLOYEES RECEIVE TRAINING FOCUSED ON UNDERSTANDING HARASSMENT, IDENTIFYING PROHIBITED CONDUCT, AND REPORTING MECHANISMS.

CONTENT AND FORMAT OF ILLINOIS HARASSMENT TRAINING

TRAINING DELIVERY METHODS
