EDUCATIONAL AND TRAINING REQUIREMENTS

PROSPECTIVE PHARMACY TECHNICIANS MUST COMPLETE SPECIFIC TRAINING PROGRAMS THAT COMPLY WITH STATE GUIDELINES OR ACQUIRE EQUIVALENT EXPERIENCE.

MINIMUM EDUCATION LEVEL

Illinois requires candidates to have a minimum education level of a high school diploma or an equivalent credential such as a GED. This basic educational foundation is essential before enrolling in any formal pharmacy technician training program or applying for certification.

APPROVED PHARMACY TECHNICIAN TRAINING PROGRAMS

CERTIFICATION AND LICENSING PROCESS

CERTIFICATION AND LICENSING ARE CRITICAL COMPONENTS OF THE ILLINOIS PHARMACY TECHNICIAN REQUIREMENTS, ENSURING THAT INDIVIDUALS ARE QUALIFIED AND AUTHORIZED TO PRACTICE. THE STATE MANDATES REGISTRATION WITH THE IDFPR AND RECOGNIZES NATIONAL CERTIFICATION EXAMINATIONS AS PART OF THE LICENSURE PROCESS.

REGISTRATION WITH IDFPR

- 2. Prepare using study materials tailored to the exam content.
- 3. Pass the exam to obtain national certification.
- 4. SUBMIT CERTIFICATION PROOF TO IDFPR DURING REGISTRATION.

LICENSE RENEWAL AND FEES

Pharmacy technician licenses in Illinois must be renewed every two years. Renewal requires submission of continuing education credits and payment of renewal fees. Failure to renew on time can result in suspension or revocation of the license.

COMPLIANCE WITH STATE AND FEDERAL LAW
