ELIGIBILITY REQUIREMENTS FOR ILLINOIS SUBSTITUTE TEACHER LICENSE

THE ILLINOIS SUBSTITUTE TEACHER LICENSE APPLICATION REQUIRES APPLICANTS TO MEET SPECIFIC ELIGIBILITY CRITERIA ESTABLISHED BY THE ILLINOIS STATE BOARD OF EDUCATION (ISBE). THESE REQUIREMENTS ENSURE THAT SUBSTITUTE TEACHERS POSSESS THE NECESSARY EDUCATIONAL BACKGROUND AND CHARACTER TO SUPPORT LEARNING ENVIRONMENTS EFFECTIVELY. ELIGIBILITY MAINLY DEPENDS ON EDUCATIONAL ATTAINMENT, RESIDENCY STATUS, AND LEGAL COMPLIANCE.

EDUCATIONAL QUALIFICATIONS

APPLICANTS MUST HAVE ATTAINED AT LEAST 60 SEMESTER HOURS OF CREDIT FROM AN ACCREDITED INSTITUTION OF HIGHER EDUCATION. THIS MINIMUM EDUCATIONAL REQUIREMENT GUARANTEES THAT SUBSTITUTE TEACHERS HAVE FOUNDATIONAL KNOWLEDGE SUITABLE FOR CLASSROOM RESPONSIBILITIES. SOME DISTRICTS MIGHT PREFER OR REQUIRE A BACHELOR'S DEGREE, BUT THE STATE MANDATES ONLY THE 60 CREDIT HOURS FOR SUBSTITUTE LICENSURE.

RESIDENCY AND LEGAL REQUIREMENTS

APPLICANTS MUST BE RESIDENTS OF ILLINOIS OR MEET SPECIFIC RESIDENCY CRITERIA ESTABLISHED BY THE STATE. ADDITIONALLY, CANDIDATES MUST COMPLY WITH ALL LEGAL MANDATES, INCLUDING PASSING CRIMINAL BACKGROUND CHECKS AND FINGERPRINTING, TO ENSURE STUDENT SAFETY AND MAINTAIN PROFESSIONAL STANDARDS WITHIN SCHOOLS.

STEP-BY-STEP APPLICATION PROCESS

THE ILLINOIS SUBSTITUTE TEACHER LICENSE APPLICATION INVOLVES A SERIES OF STEPS DESIGNED TO VERIFY ELIGIBILITY,

ELIS IS THE OFFICIAL ONLINE PLATFORM WHERE APPLICANTS SUBMIT THEIR APPLICATION, UPLOAD DOCUMENTATION, AND TRACK THE STATUS OF THEIR LICENSE REQUEST. A VALID EMAIL ADDRESS AND PERSONAL INFORMATION ARE REQUIRED TO SET UP THE ACCOUNT SECURELY.

COMPLETING AND SUBMITTING THE APPLICATION FORM

ONCE REGISTERED, APPLICANTS MUST COMPLETE THE SUBSTITUTE TEACHER LICENSE APPLICATION FORM AVAILABLE WITHIN ELIS. THIS FORM REQUIRES DETAILED PERSONAL, EDUCATIONAL, AND EMPLOYMENT INFORMATION. ACCURACY IS ESSENTIAL, AS DISCREPANCIES CAN DELAY PROCESSING TIMES. AFTER SUBMISSION, APPLICANTS PROCEED TO THE PAYMENT SECTION TO PAY THE NON-REFUNDABLE APPLICATION FEE.

FINGERPRINTING AND BACKGROUND CHECK

FOLLOWING THE ONLINE APPLICATION, APPLICANTS MUST UNDERGO FINGERPRINTING FOR A CRIMINAL BACKGROUND CHECK THROUGH AN APPROVED VENDOR. THIS STEP IS MANDATORY FOR ALL ILLINOIS TEACHING LICENSE APPLICANTS TO ENSURE COMPLIANCE WITH STATE CHILD PROTECTION LAWS. THE RESULTS ARE ELECTRONICALLY SENT TO ISBE FOR VERIFICATION.

REQUIRED DOCUMENTATION AND BACKGROUND CHECKS

SUPPORTING DOCUMENTATION IS A CRITICAL COMPONENT OF THE ILLINOIS SUBSTITUTE TEACHER LICENSE APPLICATION. PROPER AND TIMELY SUBMISSION OF THESE DOCUMENTS FACILITATES SMOOTH PROCESSING AND VERIFICATION BY LICENSING AUTHORITIES.

TRANSCRIPTS AND PROOF OF EDUCATION

APPLICANTS NEED TO PROVIDE OFFICIAL TRANSCRIPTS FROM ACCREDITED COLLEGES OR UNIVERSITIES CONFIRMING COMPLETION OF 60 SEMESTER HOURS OR HIGHER EDUCATION CREDITS. TRANSCRIPTS MUST BE SENT DIRECTLY FROM THE INSTITUTION OR UPLOADED ELECTRONICALLY THROUGH ELIS IF SUPPORTED. THESE DOCUMENTS VERIFY THAT APPLICANTS MEET THE EDUCATIONAL PREREQUISITES.

CRIMINAL BACKGROUND CHECK AND FINGERPRINTS

AS MENTIONED, ALL APPLICANTS ARE SUBJECT TO A THOROUGH CRIMINAL BACKGROUND CHECK CONDUCTED VIA FINGERPRINT SUBMISSION. THIS PROCESS SCREENS FOR ANY OFFENSES THAT MIGHT DISQUALIFY AN INDIVIDUAL FROM WORKING IN A SCHOOL SETTING. THE BACKGROUND CHECK SAFEGUARDS STUDENTS AND MAINTAINS THE INTEGRITY OF THE TEACHING PROFESSION.

ADDITIONAL DOCUMENTATION

DEPENDING ON SPECIFIC CIRCUMSTANCES, APPLICANTS MIGHT NEED TO SUBMIT ADDITIONAL DOCUMENTS SUCH AS PROOF OF RESIDENCY, IDENTIFICATION, OR PRIOR TEACHING EXPERIENCE. THESE REQUIREMENTS VARY BY DISTRICT OR LICENSE TYPE AND SHOULD BE REVIEWED CAREFULLY DURING THE APPLICATION PROCESS.

LICENSE TYPES AND VALIDITY PERIODS

ILLINOIS OFFERS MULTIPLE TYPES OF SUBSTITUTE TEACHER LICENSES, EACH TAILORED TO DIFFERENT APPLICANT QUALIFICATIONS AND INTENDED USAGE. UNDERSTANDING THE DISTINCTIONS HELPS APPLICANTS CHOOSE THE APPROPRIATE LICENSE FOR THEIR CAREER GOALS.

SHORT-TERM SUBSTITUTE LICENSE

THE SHORT-TERM SUBSTITUTE LICENSE ALLOWS INDIVIDUALS TO WORK AS SUBSTITUTES FOR UP TO 120 DAYS IN A SINGLE SCHOOL YEAR WITHIN A PARTICULAR SCHOOL DISTRICT. THIS LICENSE IS OFTEN GRANTED TO THOSE WHO MEET MINIMUM EDUCATIONAL REQUIREMENTS BUT DO NOT HOLD A FULL TEACHING LICENSE.

LONG-TERM SUBSTITUTE LICENSE

LONG-TERM SUBSTITUTE LICENSES ARE ISSUED TO INDIVIDUALS FILLING POSITIONS FOR EXTENDED PERIODS, SUCH AS A FULL SEMESTER OR SCHOOL YEAR. APPLICANTS MAY NEED TO FULFILL ADDITIONAL EDUCATIONAL OR PROFESSIONAL REQUIREMENTS TO QUALIFY FOR THIS CATEGORY.

LICENSE VALIDITY AND EXPIRATION

TYPICALLY, THE SUBSTITUTE TEACHER LICENSE IN ILLINOIS IS VALID FOR UP TO FIVE YEARS, DEPENDING ON THE LICENSE TYPE. LICENSE HOLDERS MUST MONITOR EXPIRATION DATES AND MAINTAIN COMPLIANCE WITH RENEWAL CRITERIA TO CONTINUE SUBSTITUTE TEACHING LEGALLY.

RENEWAL AND CONTINUING EDUCATION

MAINTAINING AN ACTIVE ILLINOIS SUBSTITUTE TEACHER LICENSE REQUIRES ADHERENCE TO RENEWAL PROCEDURES AND, IN SOME CASES, COMPLETION OF CONTINUING EDUCATION CREDITS. THIS SECTION OUTLINES THE REQUIREMENTS FOR LICENSE RENEWAL AND PROFESSIONAL DEVELOPMENT.

RENEWAL PROCESS

SUBSTITUTE TEACHER LICENSES MUST BE RENEWED BEFORE THEIR EXPIRATION DATE THROUGH THE ELIS SYSTEM. RENEWAL INVOLVES SUBMITTING AN APPLICATION, PAYING A RENEWAL FEE, AND PROVIDING PROOF OF ANY REQUIRED CONTINUING EDUCATION OR PROFESSIONAL DEVELOPMENT ACTIVITIES.

CONTINUING EDUCATION REQUIREMENTS

WHILE THE STATE DOES NOT MANDATE CONTINUING EDUCATION FOR ALL SUBSTITUTE LICENSES, SOME SCHOOL DISTRICTS MAY REQUIRE ONGOING TRAINING OR PROFESSIONAL DEVELOPMENT TO MAINTAIN ELIGIBILITY. IT IS ADVISABLE TO VERIFY DISTRICT-SPECIFIC POLICIES TO REMAIN COMPLIANT.

- SCHEDULE FINGERPRINTING APPOINTMENTS PROMPTLY AFTER APPLICATION SUBMISSION
- REVIEW DISTRICT-SPECIFIC RULES AND COMMUNICATE DIRECTLY WITH LOCAL EDUCATION AUTHORITIES IF NEEDED

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE GENERAL REQUIREMENTS TO APPLY FOR A SUBSTITUTE TEACHER LICENSE IN ILLINOIS?

TO APPLY FOR A SUBSTITUTE TEACHER LICENSE IN ILLINOIS, APPLICANTS MUST HAVE AT LEAST 60 SEMESTER HOURS OF COLLEGE CREDIT FROM AN ACCREDITED INSTITUTION, SUBMIT AN APPLICATION THROUGH THE ILLINOIS STATE BOARD OF EDUCATION (ISBE), COMPLETE A BACKGROUND CHECK INCLUDING FINGERPRINTING, AND PAY THE REQUIRED APPLICATION FEE.

HOW CAN I APPLY FOR AN ILLINOIS SUBSTITUTE TEACHER LICENSE?

YOU CAN APPLY FOR AN ILLINOIS SUBSTITUTE TEACHER LICENSE ONLINE THROUGH THE ILLINOIS STATE BOARD OF EDUCATION (ISBE) EDUCATOR LICENSURE INFORMATION SYSTEM (ELIS). YOU WILL NEED TO CREATE AN ACCOUNT, SUBMIT YOUR EDUCATIONAL TRANSCRIPTS, COMPLETE THE BACKGROUND CHECK, AND PAY THE APPLICATION FEE.

IS A TEACHING CERTIFICATE REQUIRED TO BECOME A SUBSTITUTE TEACHER IN ILLINOIS?

NO, A FULL TEACHING CERTIFICATE IS NOT REQUIRED. HOWEVER, APPLICANTS MUST HAVE COMPLETED AT LEAST 60 SEMESTER HOURS OF COLLEGE COURSEWORK TO QUALIFY FOR A SUBSTITUTE TEACHING LICENSE IN ILLINOIS.

HOW LONG IS AN ILLINOIS SUBSTITUTE TEACHER LICENSE VALID?

AN ILLINOIS SUBSTITUTE TEACHER LICENSE IS TYPICALLY VALID FOR 5 YEARS FROM THE DATE OF ISSUANCE. IT CAN BE RENEWED THROUGH ISBE BY COMPLETING THE NECESSARY APPLICATION AND PAYING A RENEWAL FEE.

ARE THERE ANY SPECIFIC BACKGROUND CHECKS REQUIRED FOR THE ILLINOIS SUBSTITUTE TEACHER LICENSE APPLICATION?

YES, APPLICANTS MUST UNDERGO A CRIMINAL BACKGROUND CHECK, WHICH INCLUDES FINGERPRINTING THROUGH THE ILLINOIS STATE POLICE AND THE FBI, TO ENSURE THEY MEET THE SAFETY REQUIREMENTS FOR WORKING WITH STUDENTS.
