OVERVIEW OF ILLINOIS OPTOMETRIC CONTINUING EDUCATION REQUIREMENTS

THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION (IDFPR) GOVERNS THE CONTINUING EDUCATION REQUIREMENTS FOR OPTOMETRISTS PRACTICING WITHIN THE STATE. ILLINOIS OPTOMETRIC CONTINUING EDUCATION REQUIREMENTS MANDATE THAT LICENSED OPTOMETRISTS COMPLETE A SPECIFIED NUMBER OF CE HOURS WITHIN EACH RENEWAL CYCLE TO MAINTAIN THEIR LICENSE IN GOOD STANDING. CONTINUING EDUCATION HOURS AND DEADLINES

REQUIRED NUMBER OF HOURS

Optometrists in Illinois must complete at least 30 hours of continuing education every two years. These hours ensure that practitioners maintain clinical competency and stay informed about new technologies and treatment protocols.

RENEWAL CYCLE AND DEADLINES

LIMITATIONS ON NON-CLINICAL TOPICS

ACCEPTABLE PROVIDERS AND COURSE FORMATS

• ACCREDITED OPTOMETRIC ASSOCIATIONS AND SOCIETIES

- COLLEGES AND UNIVERSITIES OFFERING HEALTH-RELATED COURSES
- STATE AND NATIONAL OPTOMETRIC BOARDS AND ORGANIZATIONS
- HEALTH CARE INSTITUTIONS PROVIDING SPECIALIZED TRAINING

ACCEPTED FORMATS

CONTINUING EDUCATION MAY BE COMPLETED THROUGH VARIOUS FORMATS, INCLUDING:

- LIVE SEMINARS AND WORKSHOPS
- ONLINE COURSES AND WEBINARS
- CONFERENCES AND SYMPOSIA
- HOME STUDY PROGRAMS WITH APPROVED TESTING COMPONENTS

REGARDLESS OF FORMAT, COURSES MUST INCLUDE MECHANISMS TO VERIFY ATTENDANCE AND LEARNING, SUCH AS QUIZZES OR CERTIFICATES OF COMPLETION.

REPORTING AND DOCUMENTATION PROCEDURES

LLINOIS OPTOMETRISTS ARE RESPONSIBLE FOR MAINTAINING ACCURATE RECORDS OF THEIR CONTINUING EDUCATION ACTIVITIES AND SUBMITTING REQUIRED DOCUMENTATION DURING LICENSE RENEWAL.

RECORDKEEPING REQUIREMENTS

LICENSEES SHOULD RETAIN CERTIFICATES OF COMPLETION, TRANSCRIPTS, OR OTHER OFFICIAL DOCUMENTATION FOR ALL CE ACTIVITIES. THE IDFPR RECOMMENDS KEEPING RECORDS FOR AT LEAST FOUR YEARS IN CASE OF AUDIT OR VERIFICATION REQUESTS.

SUBMISSION PROCESS

CONTINUING EDUCATION HOURS MUST BE REPORTED AT THE TIME OF LICENSE RENEWAL, TYPICALLY THROUGH AN ONLINE PORTAL OR RENEWAL APPLICATION. OPTOMETRISTS SHOULD CAREFULLY FOLLOW INSTRUCTIONS TO ENSURE THAT ALL CE CREDITS ARE PROPERLY CREDITED TO THEIR LICENSE.

CONSEQUENCES OF NON-COMPLIANCE
