OVERVIEW OF ILLINOIS HARASSMENT TRAINING REQUIREMENTS

HISTORICAL CONTEXT AND LEGISLATIVE BACKGROUND

WHO MUST COMPLY WITH THE 2024 TRAINING MANDATE

COVERED EMPLOYERS

SUPERVISORS, WHO HAVE GREATER RESPONSIBILITY FOR MANAGING STAFF AND ADDRESSING COMPLAINTS, TYPICALLY RECEIVE MORE COMPREHENSIVE TRAINING.

TRAINING CONTENT AND CURRICULUM SPECIFICATIONS

CUSTOMIZATION AND ACCESSIBILITY

EMPLOYERS ARE ENCOURAGED TO TAILOR TRAINING CONTENT TO THEIR SPECIFIC WORKPLACE ENVIRONMENT AND INDUSTRY. ADDITIONALLY, TRAINING MUST BE ACCESSIBLE TO ALL EMPLOYEES, INCLUDING THOSE WITH DISABILITIES OR LIMITED ENGLISH PROFICIENCY, THROUGH ACCOMMODATIONS SUCH AS TRANSLATION SERVICES OR ALTERNATIVE FORMATS.

DELIVERY METHODS AND FREQUENCY OF TRAINING

THE ILLINOIS HARASSMENT TRAINING REQUIREMENTS 2024 STIPULATE ACCEPTABLE METHODS FOR CONDUCTING TRAINING AND THE FREQUENCY WITH WHICH IT MUST OCCUR.

APPROVED TRAINING FORMATS

SUPERVISORS ARE GENERALLY REQUIRED TO UNDERGO MORE DETAILED TRAINING SESSIONS, OFTEN WITH ADDITIONAL ANNUAL REFRESHERS TO ADDRESS THEIR UNIQUE RESPONSIBILITIES IN PREVENTING AND RESPONDING TO HARASSMENT.

RECORDKEEPING AND DOCUMENTATION OBLIGATIONS

PENALTIES FOR NON-COMPLIANCE
