However, these efforts, both regionally and globally, are often highly contentious and result in conflict internally and externally. Managing migration and integration are key concerns for governments in nearly every region of the world and will take on even greater importance as globalization and technological advances shrink distances and bring us closer together. White uses an evidence-based approach to understanding immigration and economic integration to debunk the “migration myth” that sees a strong connection between these two factors. Contrary to prevailing assumptions, the main argument is that there is no substantial relationship between the international migration and regional integration, despite the political rhetoric that generates enormous fear and anxiety surrounding these issues. Instead of conflating them, countries can consider the benefits of integration policies without worrying about migration and can consider migration policies without concern for integration.
