## IRONY AND PARADOX AS VERBAL INCONGRUITY

## SITUATIONAL INCONGRUITY IN LITERARY WORKS

## UNEXPECTED OUTCOMES AND ABSURD SITUATIONS

ABSURDIST LITERATURE HEAVILY RELIES ON THIS FORM OF INCONGRUITY TO CHALLENGE RATIONALITY AND TRADITIONAL NARRATIVE COHERENCE.

## CLASSIC EXAMPLES OF SITUATIONAL INCONGRUITY

FRANZ KAFKA'S "THE METAMORPHOSIS" PRESENTS SITUATIONAL INCONGRUITY THROUGH GREGOR SAMSA'S INEXPLICABLE TRANSFORMATION INTO A GIANT INSECT. THIS SHOCKING AND ILLOGICAL EVENT CONTRASTS STARKLY WITH THE MUNDANE SETTING, EMPHASIZING THEMES OF ALIENATION AND IDENTITY. SIMILARLY, IN MARK TWAIN'S "THE ADVENTURES OF HUCKLEBERRY FINN," HUCK'S MORAL DILEMMAS AND THE SOCIETAL CONTRADICTIONS HE ENCOUNTERS CREATE NUMEROUS SITUATIONAL INCONGRUITIES THAT CRITIQUE SOCIAL INJUSTICE.

## DRAMATIC INCONGRUITY: WHEN AUDIENCE KNOWS MORE

DRAMATIC INCONGRUITY, ALSO KNOWN AS DRAMATIC IRONY, OCCURS WHEN THE AUDIENCE POSSESSES KNOWLEDGE THAT CHARACTERS LACK, CREATING TENSION, ANTICIPATION, OR HUMOR. THIS FORM OF INCONGRUITY MANIPULATES AUDIENCE EXPECTATIONS AND EMOTIONAL RESPONSES BY REVEALING DISCREPANCIES BETWEEN PERCEPTION AND REALITY WITHIN THE NARRATIVE.

# MECHANISMS OF DRAMATIC INCONGRUITY

THIS DEVICE BUILDS SUSPENSE OR COMEDIC EFFECT BY ALLOWING THE AUDIENCE TO FORESEE CONSEQUENCES UNKNOWN TO THE CHARACTERS. IT OFTEN APPEARS IN TRAGEDIES, COMEDIES, AND THRILLERS, ENHANCING ENGAGEMENT AND THEMATIC DEPTH.
