HCPCS (HEALTHCARE COMMON PROCEDURE CODING SYSTEM)

HCPCS CODES SUPPLEMENT CPT CODES AND COVER PRODUCTS, SUPPLIES, AND SERVICES NOT INCLUDED IN CPT, SUCH AS AMBULANCE SERVICES AND DURABLE MEDICAL EQUIPMENT.
