UNDERSTANDING MEDIATION ANALYSIS

MEDIATION ANALYSIS IS A STATISTICAL TECHNIQUE USED TO EXPLORE THE MECHANISM THROUGH WHICH AN INDEPENDENT VARIABLE INFLUENCES A DEPENDENT VARIABLE VIA A MEDIATOR VARIABLE. STATISTICAL METHODS FOR MEDIATION

- USE BOOTSTRAPPING METHODS TO TEST THE SIGNIFICANCE OF INDIRECT EFFECTS
- REPORT ALL RELEVANT STATISTICS CLEARLY AND ACCORDING TO APA GUIDELINES
- PROVIDE THOROUGH DESCRIPTIONS OF VARIABLES, MEASURES, AND ANALYSIS PROCEDURES
- INTERPRET MEDIATION RESULTS CAUTIOUSLY, EMPHASIZING THEORETICAL IMPLICATIONS
- INCLUDE VISUAL AIDS SUCH AS PATH DIAGRAMS WHEN APPROPRIATE (NOT IN APA TEXT BUT SUPPLEMENTARY)

BY FOLLOWING THESE GUIDELINES, RESEARCHERS CAN PRODUCE MEDIATION ANALYSIS REPORTS THAT ARE BOTH SCIENTIFICALLY RIGOROUS AND STYLISTICALLY CONSISTENT WITH APA STANDARDS, ENHANCING THE IMPACT AND CREDIBILITY OF THEIR FINDINGS.

HOW SHOULD TABLES AND FIGURES BE PRESENTED IN A MEDIATION ANALYSIS REPORT FOLLOWING APA STYLE?

TABLES AND FIGURES SHOULD BE CLEARLY LABELED WITH DESCRIPTIVE TITLES, USE APA STYLE FORMATTING (E.G., TITLE ABOVE TABLES, BELOW FIGURES), INCLUDE NOTES EXPLAINING ABBREVIATIONS OR STATISTICS, AND BE REFERENCED IN THE TEXT APPROPRIATELY.

WHAT IS THE RECOMMENDED WAY TO REPORT THE INDIRECT EFFECT IN AN APA MEDIATION ANALYSIS REPORT?
