# UNDERSTANDING MEDICARE MASSAGE THERAPY COVERAGE

MEDICARE IS A FEDERAL HEALTH INSURANCE PROGRAM PRIMARILY FOR INDIVIDUALS AGED 65 AND OLDER, AS WELL AS CERTAIN YOUNGER PEOPLE WITH DISABILITIES. WHEN IT COMES TO MASSAGE THERAPY, MEDICARE'S COVERAGE IS LIMITED AND SPECIFIC. IT GENERALLY DOES NOT COVER ROUTINE OR GENERAL MASSAGE THERAPY SERVICES THAT ARE SOUGHT FOR RELAXATION OR WELLNESS PURPOSES. HOWEVER, CERTAIN THERAPEUTIC MASSAGE TREATMENTS MIGHT BE COVERED IF THEY ARE PART OF A BROADER MEDICALLY NECESSARY TREATMENT PLAN PRESCRIBED BY A HEALTHCARE PROVIDER.

MEDICARE BENEFITS ARE DIVIDED INTO SEVERAL PARTS, WITH PART A COVERING INPATIENT CARE, PART B COVERING OUTPATIENT SERVICES, AND PART C (MEDICARE ADVANTAGE) OFFERING ALTERNATIVE PLANS THAT MAY INCLUDE ADDITIONAL BENEFITS. TYPICALLY, MASSAGE THERAPY FALLS UNDER OUTPATIENT SERVICES, AND COVERAGE IS OFTEN CONDITIONAL ON THE THERAPY BEING ESSENTIAL FOR THE TREATMENT OF A DIAGNOSED MEDICAL CONDITION.

#### MEDICARE PART B AND MASSAGE THERAPY

MEDICARE PART B MAY COVER MASSAGE THERAPY ONLY WHEN IT IS PERFORMED BY A QUALIFIED HEALTHCARE PROFESSIONAL AS PART OF A TREATMENT PLAN FOR A SPECIFIC MEDICAL DIAGNOSIS. FOR EXAMPLE, MASSAGE THERAPY MIGHT BE COVERED IF IT IS INTEGRATED INTO PHYSICAL THERAPY OR OCCUPATIONAL THERAPY PRESCRIBED FOR CONDITIONS SUCH AS CHRONIC PAIN, MUSCULOSKELETAL INJURIES, OR POST-SURGICAL REHABILITATION.

# MEDICARE ADVANTAGE (PART C) PLANS

Some Medicare Advantage plans may offer additional benefits not included in Original Medicare, potentially including coverage for massage therapy. These benefits vary widely by plan and geographic location, and beneficiaries should review their specific plan details to determine coverage eligibility for massage therapy services.

# ELIGIBILITY CRITERIA FOR MEDICARE MASSAGE THERAPY

To qualify for Medicare coverage of massage therapy, certain eligibility requirements and conditions must be met. These criteria ensure that the therapy is medically necessary and appropriately administered.

# MEDICAL NECESSITY REQUIREMENT

MEDICARE REQUIRES THAT MASSAGE THERAPY BE DEEMED MEDICALLY NECESSARY BY A LICENSED HEALTHCARE PROVIDER. ## QUALIFIED PROVIDERS AND DOCUMENTATION

COVERAGE TYPICALLY APPLIES ONLY WHEN MASSAGE THERAPY IS PROVIDED BY A LICENSED OR CERTIFIED HEALTHCARE PROFESSIONAL, SUCH AS A PHYSICAL THERAPIST OR OCCUPATIONAL THERAPIST, WHO DOCUMENTS THE TREATMENT IN THE PATIENT'S MEDICAL RECORD. THE DOCUMENTATION SHOULD CLEARLY SHOW THE MEDICAL NECESSITY AND EXPECTED BENEFITS OF THE MASSAGE THERAPY IN THE PATIENT'S RECOVERY PROCESS.

#### CONDITIONS COMMONLY COVERED

MEDICARE MAY COVER MASSAGE THERAPY WHEN IT IS RELATED TO:

- Post-surgical rehabilitation
- CHRONIC MUSCULOSKELETAL CONDITIONS
- SEVERE PAIN MANAGEMENT
- NEUROLOGICAL DISORDERS REQUIRING PHYSICAL THERAPY
- RESTRICTED MOBILITY DUE TO INJURY OR ILLNESS

# LIMITATIONS AND EXCLUSIONS IN COVERAGE

WHILE MEDICARE DOES PROVIDE SOME COVERAGE FOR MASSAGE THERAPY UNDER SPECIFIC CONDITIONS, THERE ARE SIGNIFICANT LIMITATIONS AND EXCLUSIONS TO BE AWARE OF.

## NON-COVERED SERVICES

ROUTINE MASSAGE THERAPY FOR GENERAL WELLNESS, STRESS RELIEF, OR COSMETIC PURPOSES IS NOT COVERED BY MEDICARE. ADDITIONALLY, MASSAGE SERVICES PROVIDED BY UNLICENSED PRACTITIONERS OR THOSE NOT INTEGRATED INTO A MEDICALLY NECESSARY TREATMENT PLAN ARE EXCLUDED.

# FREQUENCY AND DURATION LIMITS

MEDICARE MAY IMPOSE LIMITS ON THE FREQUENCY AND DURATION OF COVERED MASSAGE THERAPY SESSIONS. COVERAGE TYPICALLY DEPENDS ON ONGOING ASSESSMENTS OF MEDICAL NEED AND PROGRESS, AND THERAPY MUST BE JUSTIFIED REGULARLY BY THE TREATING HEALTHCARE PROVIDER.

#### **OUT-OF-POCKET COSTS**

EVEN WHEN MASSAGE THERAPY IS COVERED, MEDICARE BENEFICIARIES MAY BE RESPONSIBLE FOR COPAYMENTS, COINSURANCE, OR DEDUCTIBLES ASSOCIATED WITH THE SERVICES. IT IS IMPORTANT TO REVIEW SPECIFIC PLAN DETAILS AND DISCUSS POTENTIAL COSTS WITH PROVIDERS BEFORE BEGINNING TREATMENT.

# ALTERNATIVE OPTIONS FOR MASSAGE THERAPY COVERAGE

SINCE ORIGINAL MEDICARE HAS LIMITED COVERAGE FOR MASSAGE THERAPY, BENEFICIARIES OFTEN EXPLORE ALTERNATIVE OPTIONS TO ACCESS THESE SERVICES AFFORDABLY.

# MEDICARE SUPPLEMENT (MEDIGAP) PLANS

MEDIGAP PLANS MAY HELP COVER SOME OUT-OF-POCKET COSTS RELATED TO MEDICALLY NECESSARY MASSAGE THERAPY IF IT IS COVERED UNDER ORIGINAL MEDICARE. HOWEVER, THESE PLANS DO NOT TYPICALLY EXTEND COVERAGE TO MASSAGE THERAPY SERVICES THAT MEDICARE DOES NOT COVER.

#### MEDICAID AND STATE PROGRAMS

In some states, Medicaid or other state health programs may provide coverage or assistance for massage therapy, particularly for qualifying medical conditions. Eligibility and benefits vary significantly by state.

#### PRIVATE INSURANCE AND DISCOUNT PROGRAMS

Some private insurance plans and wellness programs offer coverage or discounts for massage therapy. Beneficiaries should investigate additional insurance options or wellness memberships that might include massage benefits.

# FLEXIBLE SPENDING ACCOUNTS (FSAs) AND HEALTH SAVINGS ACCOUNTS (HSAs)

## CONSIDERATIONS FOR MEDICARE BENEFICIARIES

MEDICARE RECIPIENTS INTERESTED IN MASSAGE THERAPY FOR PAIN MANAGEMENT OR REHABILITATION SHOULD WORK CLOSELY WITH THEIR HEALTHCARE PROVIDERS TO ENSURE TREATMENTS MEET MEDICARE'S MEDICAL NECESSITY CRITERIA. #### UNDER WHAT CONDITIONS MIGHT MEDICARE COVER MASSAGE THERAPY?

MEDICARE MAY COVER MASSAGE THERAPY IF IT IS DEEMED MEDICALLY NECESSARY AND IS INTEGRAL TO THE TREATMENT OF A SPECIFIC CONDITION, SUCH AS POST-SURGICAL REHABILITATION OR CHRONIC PAIN MANAGEMENT, AND IS PROVIDED BY A QUALIFIED HEALTHCARE PROFESSIONAL AS PART OF A BROADER THERAPY PLAN.

#### IS MASSAGE THERAPY COVERED UNDER MEDICARE PART B?

MEDICARE PART B TYPICALLY DOES NOT COVER MASSAGE THERAPY UNLESS IT IS PART OF A COVERED SERVICE LIKE PHYSICAL THERAPY OR OCCUPATIONAL THERAPY PRESCRIBED BY A PHYSICIAN AND PROVIDED BY AN APPROVED PROVIDER.

#### CAN MEDICARE ADVANTAGE PLANS COVER MASSAGE THERAPY?

Some Medicare Advantage (Part C) plans may offer additional benefits, including coverage for massage therapy. Coverage varies by plan, so it's important to check with the specific Medicare Advantage provider for details.

# ARE THERE ANY REQUIREMENTS FOR MASSAGE THERAPISTS TO BE COVERED BY MEDICARE?

FOR MASSAGE THERAPY TO BE COVERED UNDER MEDICARE, THERAPISTS USUALLY NEED TO BE LICENSED OR CERTIFIED AND PROVIDE SERVICES UNDER THE SUPERVISION OF A PHYSICIAN OR AS PART OF A COVERED THERAPY PROGRAM.

## DOES MEDICARE COVER MASSAGE THERAPY FOR PAIN MANAGEMENT?

MEDICARE DOES NOT TYPICALLY COVER MASSAGE THERAPY SOLELY FOR PAIN MANAGEMENT UNLESS IT IS PART OF A MEDICALLY NECESSARY TREATMENT PLAN PRESCRIBED BY A PHYSICIAN AND FALLS UNDER COVERED THERAPY SERVICES.

#### HOW CAN I FIND OUT IF MY MASSAGE THERAPY IS COVERED BY MEDICARE?

YOU SHOULD CONSULT YOUR HEALTHCARE PROVIDER AND MEDICARE PLAN DOCUMENTS. ADDITIONALLY, CONTACTING MEDICARE DIRECTLY OR YOUR MEDICARE ADVANTAGE PLAN PROVIDER CAN CLARIFY IF MASSAGE THERAPY SERVICES ARE COVERED IN YOUR

#### ARE THERE LIMITS ON HOW MANY MASSAGE THERAPY SESSIONS MEDICARE WILL COVER?

IF MASSAGE THERAPY IS COVERED UNDER MEDICARE AS PART OF PHYSICAL OR OCCUPATIONAL THERAPY, COVERAGE LIMITS AND SESSION CAPS MAY APPLY BASED ON MEDICAL NECESSITY AND PLAN GUIDELINES.

# DOES MEDICARE COVER MASSAGE THERAPY FOR CONDITIONS LIKE FIBROMYALGIA OR ARTHRITIS?
