PROGRAMS TYPICALLY COMBINE CLASSROOM INSTRUCTION WITH PRACTICAL EXPERIENCE, FOCUSING ON PHARMACOLOGY, MEDICATION ADMINISTRATION TECHNIQUES, AND PATIENT CARE PROTOCOLS. ELIGIBILITY REQUIREMENTS FOR MEDICATION AIDE TRAINING

HEALTH AND BACKGROUND SCREENING

CANDIDATES ARE TYPICALLY REQUIRED TO UNDERGO HEALTH SCREENINGS, INCLUDING TUBERCULOSIS TESTS AND IMMUNIZATIONS, TO ENSURE THEY ARE FIT FOR CLINICAL TRAINING. BACKGROUND CHECKS MAY ALSO BE MANDATED TO VERIFY THE CANDIDATE'S SUITABILITY FOR WORKING WITH VULNERABLE POPULATIONS.

CURRICULUM AND TRAINING COMPONENTS

CERTIFICATION AND LICENSING PROCESS

REGULATORY AND LEGAL CONSIDERATIONS

STATE REGULATIONS

THE NEW JERSEY BOARD OF NURSING OVERSEES THE CERTIFICATION AND PRACTICE STANDARDS FOR MEDICATION AIDES. HOW LONG DOES MEDICATION AIDE TRAINING IN NEW JERSEY USUALLY TAKE?

MEDICATION AIDE TRAINING PROGRAMS IN NEW JERSEY GENERALLY TAKE BETWEEN 40 TO 60 HOURS TO COMPLETE, INCLUDING BOTH CLASSROOM INSTRUCTION AND CLINICAL PRACTICE, DEPENDING ON THE SPECIFIC PROGRAM AND PROVIDER.

IS MEDICATION AIDE TRAINING IN NEW JERSEY STATE-APPROVED?

YES, MEDICATION AIDE TRAINING PROGRAMS IN NEW JERSEY MUST BE APPROVED BY THE NEW JERSEY BOARD OF NURSING TO ENSURE THEY MEET STATE STANDARDS AND PROPERLY PREPARE STUDENTS FOR CERTIFICATION AND PRACTICE.
