SCOPE OF PRACTICE AND SUPERVISION

CERTIFIED MEDICATION AIDES IN NEW JERSEY ARE AUTHORIZED TO ADMINISTER MEDICATIONS ONLY UNDER THE DIRECT SUPERVISION OF LICENSED NURSES. THE SCOPE OF PRACTICE IS CLEARLY DEFINED TO MAINTAIN PATIENT SAFETY AND ENSURE ADHERENCE TO REGULATORY STANDARDS.

CAREER OPPORTUNITIES FOR CERTIFIED MEDICATION AIDES

SALARY AND ADVANCEMENT
