UNDERSTANDING POLITICAL ASYLUM IN NEW YORK

POLITICAL ASYLUM IS A FORM OF INTERNATIONAL PROTECTION GRANTED TO INDIVIDUALS WHO HAVE FLED THEIR HOME COUNTRIES DUE TO PERSECUTION OR A WELL-FOUNDED FEAR OF PERSECUTION BASED ON RACE, RELIGION, NATIONALITY, MEMBERSHIP IN A PARTICULAR SOCIAL GROUP, OR POLITICAL OPINION. NEW YORK, WITH ITS LARGE IMMIGRANT POPULATION AND STATUS AS A HUB FOR INTERNATIONAL DIPLOMACY AND ADVOCACY, IS A SIGNIFICANT LOCATION FOR ASYLUM SEEKERS. INDIVIDUALS SEEKING POLITICAL ASYLUM IN NEW YORK MUST DEMONSTRATE THAT RETURNING TO THEIR HOME COUNTRY WOULD EXPOSE THEM TO SERIOUS HARM OR THREATS TO THEIR LIFE AND FREEDOM.

DEFINITION AND PURPOSE OF POLITICAL ASYLUM

POLITICAL ASYLUM PROVIDES LEGAL PROTECTION AND RESIDENCY IN THE UNITED STATES TO THOSE WHO CANNOT SAFELY REMAIN IN THEIR NATIVE COUNTRIES. IT SERVES AS A HUMANITARIAN SAFEGUARD FOR VICTIMS OF POLITICAL OPPRESSION, TORTURE, OR VIOLENCE. THE ASYLUM STATUS ALLOWS RECIPIENTS TO LIVE AND WORK LEGALLY IN THE U.S. AND MAY EVENTUALLY LEAD TO PERMANENT RESIDENCY AND CITIZENSHIP.

NEW YORK'S ROLE IN ASYLUM CASES

NEW YORK IS HOME TO NUMEROUS IMMIGRATION COURTS AND AGENCIES THAT HANDLE ASYLUM CASES, INCLUDING THE U.S. CITIZENSHIP AND IMMIGRATION SERVICES (USCIS) AND THE EXECUTIVE OFFICE FOR IMMIGRATION REVIEW (EOIR). THE STATE'S DIVERSE IMMIGRANT COMMUNITIES AND NUMEROUS NONPROFIT ORGANIZATIONS ALSO PROVIDE SUPPORT SERVICES, MAKING IT A CRITICAL AREA FOR ASYLUM LITIGATION AND ADVOCACY.

THE ROLE OF A POLITICAL ASYLUM LAWYER IN NEW YORK

GROUND FOR ASYLUM ELIGIBILITY

AN ASYLUM APPLICANT MUST PROVE THAT THEY HAVE SUFFERED PERSECUTION OR HAVE A WELL-FOUNDED FEAR OF PERSECUTION BASED ON AT LEAST ONE OF THE FOLLOWING FIVE PROTECTED GROUNDS:

- RACE
- RELIGION
- NATIONALITY
- MEMBERSHIP IN A PARTICULAR SOCIAL GROUP
- POLITICAL OPINION

PERSECUTION INCLUDES THREATS TO LIFE OR FREEDOM, PHYSICAL HARM, OR SEVERE DISCRIMINATION. A POLITICAL ASYLUM LAWYER IN NEW YORK CAN HELP DETERMINE WHETHER AN APPLICANT'S SITUATION MEETS THESE CRITERIA.

ADDITIONAL ELIGIBILITY CONSIDERATIONS

APPLICANTS MUST ALSO DEMONSTRATE THAT THEY HAVE APPLIED FOR ASYLUM WITHIN ONE YEAR OF ARRIVING IN THE UNITED STATES UNLESS THEY QUALIFY FOR AN EXCEPTION. FURTHERMORE, CERTAIN CRIMINAL CONVICTIONS OR SECURITY-RELATED ISSUES CAN DISQUALIFY INDIVIDUALS FROM ASYLUM ELIGIBILITY.

THE POLITICAL ASYLUM APPLICATION PROCESS

IF THE APPLICANT IS DETAINED OR PLACED IN REMOVAL PROCEEDINGS, THEY MAY UNDERGO A CREDIBLE FEAR INTERVIEW TO DETERMINE ELIGIBILITY FOR ASYLUM. CASES THEN PROCEED TO IMMIGRATION COURT, WHERE A JUDGE REVIEWS THE EVIDENCE AND HEARS TESTIMONY. DECISION AND APPEALS
