Any changes to the way in which elections are carried out must be accompanied by rigorous research and testing; the absence of such research and testing was a major failing that led to the problems of 3 May. There were failings on the part of the Scotland Office, where lengthy delays disrupted election planning and led to weak contingency arrangements. The Electoral Commission did not do enough to warn of potential problems with the ballot. The use of e-counting has been subject to particular criticism. Although electronic counting may have the potential to produce results more quickly, in these elections it did not operate efficiently or transparently. Any future proposals must place the needs of the voter and the interests of transparency far above the limitations of any given technology.
