PREPARATION TIPS FOR POLYGRAPH EXAMINATIONS

PROPER PREPARATION CAN HELP CANDIDATES APPROACH POLYGRAPH TESTS WITH CONFIDENCE. UNDERSTANDING THE NATURE OF POLYGRAPH TEST QUESTIONS FOR BORDER PATROL AND BEING TRUTHFUL THROUGHOUT THE PROCESS ARE ESSENTIAL STEPS.

HONESTY AS THE BEST APPROACH
