KEY ELEMENTS OF A SWIMMING POOL CONSTRUCTION CONTRACT

PERMITS AND APPROVALS

THE CONTRACT SHOULD CLARIFY WHO IS RESPONSIBLE FOR OBTAINING NECESSARY PERMITS AND ENSURING COMPLIANCE WITH LOCAL BUILDING CODES AND REGULATIONS. THIS PROTECTS BOTH PARTIES FROM LEGAL COMPLICATIONS RELATED TO UNAUTHORIZED CONSTRUCTION.

COMMON CLAUSES IN SWIMMING POOL CONSTRUCTION CONTRACTS

DOCUMENT ALL COMMUNICATIONS

LEGAL CONSIDERATIONS AND COMPLIANCE

COMMUNICATION PROTOCOLS
