THIS CERTIFICATION ENSURES THAT TEACHERS POSSESS THE KNOWLEDGE AND SKILLS NECESSARY TO DESIGN INDIVIDUALIZED EDUCATION PROGRAMS (IEPs), IMPLEMENT SPECIALIZED INSTRUCTIONAL STRATEGIES, AND COLLABORATE WITH FAMILIES AND MULTIDISCIPLINARY TEAMS. New Jersey's DEPARTMENT OF EDUCATION ESTABLISHES STANDARDS TO GUARANTEE THAT CERTIFIED TEACHERS ARE PREPARED TO MEET THE UNIQUE CHALLENGES FACED BY STUDENTS WITH DISABILITIES. THIS CREDENTIAL IS A CRITICAL COMPONENT IN PROMOTING INCLUSIVE EDUCATION AND IMPROVING STUDENT OUTCOMES IN DIVERSE CLASSROOM ENVIRONMENTS.

SCOPE AND PURPOSE OF THE CERTIFICATION

CERTIFICATION REQUIREMENTS AND ELIGIBILITY

APPLICATION PROCESS FOR CERTIFICATION

THE APPLICATION PROCESS FOR THE TEACHER OF STUDENTS WITH DISABILITIES CERTIFICATION IN NJ INVOLVES SUBMITTING DOCUMENTATION TO THE NEW JERSEY DEPARTMENT OF EDUCATION. APPROVED PREPARATION PROGRAMS AND COURSEWORK

NEW JERSEY REQUIRES CANDIDATES TO COMPLETE AN APPROVED TEACHER PREPARATION PROGRAM SPECIFICALLY DESIGNED FOR SPECIAL EDUCATION. THESE PROGRAMS PROVIDE THE ACADEMIC FOUNDATION AND PRACTICAL EXPERIENCE NECESSARY TO TEACH STUDENTS WITH DISABILITIES EFFECTIVELY. COURSEWORK EMPHASIZES BOTH THEORETICAL KNOWLEDGE AND APPLIED SKILLS.

PRAXIS SPECIAL EDUCATION TEST

ONE OF THE PRIMARY ASSESSMENTS IS THE PRAXIS SPECIAL EDUCATION EXAM, WHICH IS RECOGNIZED BY THE NEW JERSEY DEPARTMENT OF EDUCATION. THIS EXAMINATION COVERS TOPICS SUCH AS INSTRUCTIONAL PLANNING, ASSESSMENT, AND PROFESSIONAL RESPONSIBILITIES. PASSING SCORES ARE REQUIRED FOR CERTIFICATION ELIGIBILITY.

ADDITIONAL TESTING REQUIREMENTS

DEPENDING ON THE CANDIDATE'S BACKGROUND, ADDITIONAL EXAMS, SUCH AS BASIC SKILLS OR CONTENT AREA TESTS, MAY BE REQUIRED. THESE ASSESSMENTS ENSURE THAT TEACHERS POSSESS THE FOUNDATIONAL KNOWLEDGE NEEDED TO SUCCEED IN THE CLASSROOM AND MEET STATE STANDARDS.

THE TEACHER OF STUDENTS WITH DISABILITIES CERTIFICATION IN NEW JERSEY IS A CREDENTIAL THAT AUTHORIZES EDUCATORS TO TEACH STUDENTS WITH DISABILITIES FROM PRESCHOOL THROUGH GRADE 12, ENSURING THEY HAVE THE SKILLS AND KNOWLEDGE TO SUPPORT DIVERSE LEARNING NEEDS.

WHAT ARE THE ELIGIBILITY REQUIREMENTS FOR THE TEACHER OF STUDENTS WITH DISABILITIES CERTIFICATION IN NJ?

CANDIDATES MUST PASS THE PRAXIS SPECIAL EDUCATION: CORE KNOWLEDGE AND APPLICATIONS EXAM, AND IN SOME CASES, THE PRAXIS PRINCIPLES OF LEARNING AND TEACHING (PLT) EXAM, DEPENDING ON THE SPECIFIC CERTIFICATION LEVEL SOUGHT.

CAN OUT-OF-STATE TEACHERS OBTAIN THE TEACHER OF STUDENTS WITH DISABILITIES CERTIFICATION IN NEW JERSEY?

YES, OUT-OF-STATE TEACHERS CAN OBTAIN NEW JERSEY CERTIFICATION THROUGH RECIPROCITY IF THEY HOLD A VALID SPECIAL EDUCATION TEACHING CERTIFICATE FROM ANOTHER STATE AND MEET NEW JERSEY'S REQUIREMENTS, INCLUDING PASSING REQUIRED EXAMS AND COMPLETING ANY ADDITIONAL STATE-MANDATED TRAINING.

ARE THERE DIFFERENT LEVELS OR ENDORSEMENTS FOR THE TEACHER OF STUDENTS WITH DISABILITIES CERTIFICATION IN NJ?

YES, NEW JERSEY OFFERS VARIOUS ENDORSEMENTS UNDER THE TEACHER OF STUDENTS WITH DISABILITIES CERTIFICATION, INCLUDING PRESCHOOL DISABILITIES, ELEMENTARY, MIDDLE SCHOOL, AND SECONDARY LEVELS, ALLOWING EDUCATORS TO SPECIALIZE IN TEACHING SPECIFIC AGE GROUPS OR DISABILITY CATEGORIES.
