Indeed, for Share, to forego the possibility of reconstructing such traumas in favor of an exclusively

here-and-now interpretive approach is to risk perpetuating the trauma in all its pathogenicity. By contrast, when trauma can be reexperienced meaningfully in treatment, both behavioral reenactments and trauma-related transference issues can be dramatically clarified. Demonstrating her point with vivid clinical case reports, Share emphasizes the special value of dream interpretation in recovering the full psychological impact of events that occurred in the first few years of life. Through the imagistic dimension of dream formation, unconscious traumatic memories gain access to an expressive vehicle through which the patient, aided by the analyst's understanding, can begin to work through early experiences that have heretofore been dimly known but not felt.
