OVERVIEW OF THE SIC CODE SYSTEM

THE STANDARD INDUSTRIAL CLASSIFICATION (SIC) SYSTEM IS A NUMERICAL CODING SYSTEM ESTABLISHED TO CATEGORIZE INDUSTRIES BY THEIR PRIMARY BUSINESS ACTIVITIES. SIC CODES ARE FORMATTED AS FOUR-DIGIT NUMBERS, WHERE THE FIRST TWO DIGITS IDENTIFY THE MAJOR INDUSTRY GROUP, THE THIRD DIGIT SPECIFIES THE INDUSTRY GROUP WITHIN THAT MAJOR GROUP, AND THE FOURTH DIGIT IDENTIFIES A MORE DETAILED INDUSTRY CLASSIFICATION. FOR EXAMPLE, CODES IN THE 70 SERIES GENERALLY RELATE TO SERVICES, INCLUDING BUSINESS SERVICES SUCH AS CONSULTING.

DESPITE THE EMERGENCE OF NEWER CLASSIFICATION SYSTEMS, SIC CODES CONTINUE TO BE USED FOR LEGACY REPORTING, HISTORICAL DATA COMPARISONS, AND SPECIFIC REGULATORY REPORTING. MANY COMPANIES STILL REFERENCE SIC CODES FOR INSURANCE, TAXATION, AND COMPLIANCE PURPOSES, MAKING KNOWLEDGE OF THESE CODES ESSENTIAL FOR BUSINESSES IN THE TECHNOLOGY CONSULTING SECTOR.
