The statutory mechanical royalty rate for physical and permanent digital downloads in the U.S. is currently set at 9.1 cents per copy for songs five minutes or less, or 1.75 cents per minute for songs longer than five minutes. Streaming mechanical royalties are calculated differently, often as a percentage of revenue generated by interactive streams.
