Prior to the pandemic Family Practice Physicians and Advanced Clinical Providers (ACP) surveyed in America (according to SE Healthcare Quality Consulting, Feb. 2021) found that 49% showed symptoms of "burnout" prior to the COVID-19 pandemic and at the peak of the pandemic 100% of those surveyed showed symptoms of "burnout".
