OVERVIEW OF WOMEN OWNED BUSINESS TAX CREDITS

FEDERAL VS. STATE PROGRAMS

ELIGIBILITY CRITERIA FOR TAX CREDITS

ELIGIBILITY REQUIREMENTS FOR WOMEN OWNED BUSINESS TAX CREDITS VARY DEPENDING ON THE PROGRAM BUT GENERALLY INCLUDE VERIFICATION OF BUSINESS OWNERSHIP, SIZE, AND OPERATIONAL STATUS. BUSINESS SIZE AND CLASSIFICATION

CREDITS OFTEN TARGET SMALL TO MEDIUM-SIZED BUSINESSES, WITH SPECIFIC DEFINITIONS BASED ON REVENUE, NUMBER OF EMPLOYEES, OR INDUSTRY CLASSIFICATION. WOMEN OWNED BUSINESSES MUST VERIFY THAT THEY FALL WITHIN THESE PARAMETERS TO QUALIFY.

INDUSTRY AND LOCATION REQUIREMENTS

CERTAIN TAX CREDITS ARE LIMITED TO BUSINESSES OPERATING WITHIN PARTICULAR INDUSTRIES, SUCH AS MANUFACTURING, TECHNOLOGY, OR RETAIL. ADDITIONALLY, GEOGRAPHIC RESTRICTIONS MAY APPLY, FOCUSING ON ECONOMICALLY DISADVANTAGED ZONES OR SPECIFIC STATES AIMING TO PROMOTE LOCAL DEVELOPMENT.

RESEARCH AND DEVELOPMENT (R&D) TAX CREDITS ENCOURAGE INNOVATION BY REDUCING TAX LIABILITY RELATED TO

QUALIFYING RESEARCH ACTIVITIES. WOMEN OWNED BUSINESSES ENGAGED IN DEVELOPING NEW PRODUCTS OR TECHNOLOGIES CAN BENEFIT FROM THESE INCENTIVES.

STATE-SPECIFIC TAX CREDITS

GRANT AND LOAN PROGRAMS

VARIOUS GOVERNMENT AND PRIVATE SECTOR GRANTS AND LOANS ARE TARGETED AT WOMEN ENTREPRENEURS, OFTEN IN CONJUNCTION WITH TAX CREDITS TO PROVIDE COMPREHENSIVE FINANCIAL SUPPORT.

WHAT IS A WOMEN-OWNED BUSINESS TAX CREDIT?

A WOMEN-OWNED BUSINESS TAX CREDIT IS A FINANCIAL INCENTIVE PROVIDED BY FEDERAL, STATE, OR LOCAL GOVERNMENTS TO ENCOURAGE THE GROWTH AND SUPPORT OF BUSINESSES OWNED AND OPERATED BY WOMEN. THESE CREDITS REDUCE THE AMOUNT OF TAX THE BUSINESS OWES.

ARE THERE FEDERAL TAX CREDITS SPECIFICALLY FOR WOMEN-OWNED BUSINESSES?

CURRENTLY, THERE ARE NO SPECIFIC FEDERAL TAX CREDITS EXCLUSIVELY FOR WOMEN-OWNED BUSINESSES. HOWEVER, WOMEN-OWNED BUSINESSES MAY QUALIFY FOR GENERAL SMALL BUSINESS TAX CREDITS AND INCENTIVES, AS WELL AS GRANTS AND PROGRAMS AIMED AT SUPPORTING WOMEN ENTREPRENEURS.

WHAT TYPES OF TAX CREDITS CAN WOMEN-OWNED BUSINESSES TYPICALLY QUALIFY FOR?

WOMEN-OWNED BUSINESSES MAY QUALIFY FOR VARIOUS TAX CREDITS SUCH AS THE WORK OPPORTUNITY TAX CREDIT (WOTC), DISABLED ACCESS CREDIT, SMALL BUSINESS HEALTH CARE TAX CREDIT, AND STATE-SPECIFIC CREDITS DESIGNED TO ENCOURAGE BUSINESS DEVELOPMENT AMONG WOMEN ENTREPRENEURS.
